 - 4.1. Highways issues: Highways to be thanked for cleaning out the gullies and filling in various potholes down The Street
 - 4.1.1. Drains on The Street Opposite Church Farm Barns, though the drain had been cleaned out it still does not drain. Clerk to ask Highways to investigate
 - 4.1.2. Drains on Mill Road The Drain opposite The Old Forge was missed when cleaning as it was under a puddle at the time. Clerk to ask Highways to clean.
 - 4.1.3. Pothole on Mill Road. Clerk to contact Highways
 - 4.1.4.Straw and mud on The Street. Highways were looking at discussing this with the Moore Farm, nothing happened, not heard back from Highways. Clerk to contact Highways.
 - 4.2. Lay-by on A1067 going towards Fakenham. Closure of lay-by to deter fly tipping. Highways are not happy to close the lay-by. They may be happy to cut back the vegetation, so the Lay-by is not screened from view, Highways are going to look at doing this. While BB attended the Annual Parish Council Meeting, we raised this issue, he will investigate why Highways will not close the Lay-by and get back to us. Email also sent to Gordon Bambridge to see if there is any further news on the temporary camera to catch possible fly tipping. Not heard anything back. Clerk to chase.
 - 4.3. Litter bin by bus shelter not being emptied. Emailed Breckland Council and the bin has been put on their schedule for future rounds. This seems to be happening now.
