Mentioned about the straw coming off at certain properties where the hedges are over hanging "The Street" and dragging straw from passing vehicles. Highways would like us to send letters to those residents before they get involved. These have been sent and copies sent to Highways.
  - 4.4. We are still waiting on the signages from Breckland for Dog Fouling and Fly tipping, a Breckland representative is visiting the two Layby, on the 2<sup>nd</sup> October, to see if the signs can be put up without having to put in new posts.
